Dear colleagues!

At the end of last year the European Commission has presented proposals that will considerably influence the profession of Chartered Engineers in Europe: The whole system of public procurement as well as the system of professional recognition is currently modernized.

Some of the positive aspects in those proposals – like for example the measures for better SME participation to public procurement procedures or the final concept of a “professional card” which is now meant to be a digital certificate issued by competent authorities only – clearly show that the on-going activities of the ECEC are not in vain and that we have already achieved some good results.

Due to the numerous different interests on European level these results are of course only compromises, so there is still a lot to do for us.

Let's see this as a motivation for the forthcoming meetings with the European Commission and the European Parliament on the ECEC positions on Professional Recognition and Public Procurement.

To enforce the activities of the ECEC all member organisations are asked to promote the ECEC positions on the Public Procurement Directive and on the Professional Qualifications Directive and to inform their Members of European Parliament and their national competent authorities about them.

NEWS FROM EUROPE

Modernization of the European Public Procurement legislation:

The modernization package on the European Public Procurement legislation was presented in December 2011.

Some of the many points in the proposals are measures to enhance access to Public Procurement procedures for SME, changes in

the negotiated procedure, a new innovative procedure, the possibility of strategic procurement, the use of life-cycle costs as award criteria, a new governance system etc. The ECEC has already reacted - the ECEC position was finalized in March 2012 and can be found here:

ECEC President and Board are now arranging meetings with competent EC members and with the rapporteur/shadow rapporteurs in the competent IMCO Committee of the European Parliament.

Discussions are on-going in the working group of the European Council as well as in the European Parliament. Already in December the report of the IMCO committee on PP will be adopted in the plenary session.

Modernization of the Professional Qualifications Directive:

The proposal for the modernization of the system of professional recognition in Europe was presented in December 2011.

Some of the many points in the proposal:

An accelerated professional recognition via a digital “professional card” in the IMI is foreseen. The five qualification levels of Art.11 are kept but only as a benchmark and they can also be described with the European Credit Transfer and Accumulation System (ECTS). Instead of the Common Platform there is going to be a new system of common training principles that can lead to a kind of “automatic recognition”. The European Commission also wants to introduce – based on some decisions of the European Court of Justice – a partial access to the profession. competent IMCO Committee of the European Parliament.

Discussions are on-going in the working group of the European Council as well as in the European Parliament. Already in December the report of the IMCO Committee on PQD will be adopted in the plenary session.

Freedom of Services:

The European Commission – with the help of the member states – is currently doing a so-called „coherence-test“ to see how the Services Directive and similar instruments are really working in practice. Depending on the results of the test the Commission will decide on the necessity of further measures. Already now in some member states a reduction of the number of regulated professions has been started / is in planning.

Engineers yesterday, today and tomorrow and their important role in our society – this was the main theme of the Day of Slovak Engineers which the Slovak Chamber of Civil Engineers SKSI organized on March 16, 2012, in Bratislava.

"The Construction Sector in Slovakia has achieved a great progress in recent years, and the Slovak Chamber of Civil Engineers has played an important role in this progress," declared the First Lady of the Slovak Republic Mrs. Silvia Gašparovičová, who held the auspices of the Day of Slovak Engineers. Honorary Membership was also granted to Josef Robl, President of the European Council of Engineering Chambers and to Dimitar Natchev, President of the Chamber of Engineers in Investment Design KIIP Sofia from Bulgaria.
